Nominations for the Annual Rimm Award

In memory of Judge Benjamin A. Rimm and in recognition of his personal and professional integrity, his devotion to the legal profession, his dedication to the people of Atlantic County and his service as a judge, the Atlantic County Bar Association will present the Annual Honorable Benjamin A. Rimm Award in September of this year. The award is given each year to the young lawyer who best displays the qualities in recognition of which the award is established.

The Qualifications of the Recipient are as follows:

A member of the Atlantic County Bar Association

A resident of Atlantic County

Maintains an office for the private practice of law in Atlantic County, or is employed as an attorney-at-law with his/her office maintained in Atlantic County by the employer.

A member of the Bar of the State of NJ for not more than 10 years at the time of the presentation of the award.

Chosen by the Committee of the Association established to make such choice and based on the following considerations:

The attitude, demeanor and relationship between the recipient and the general public, the fellow members of the Bar and Judiciary.

The quality of the recipient's performance as a lawyer.

The nature of the recipient's public service, as an elected public official, an appointed public official or his/her general public service in the PRO BONO PUBLIC AREA.

The recipient's participation in civic activities benefiting the residents of Atlantic County.

The recipient's activities in philanthropic activities benefiting the residents of Atlantic County.

The recipient's integrity and the respect which the fellow members of the Bar Association have for his/her responsible performance as a lawyer.

The Association has established a permanent standing committee to select the recipient. The committee consists of Doug Stanger, Edward Goldstein and the President-Elect of the Atlantic County Bar Association.

There is established the Honorable Benjamin A. Rimm Award Fund as a charity with the Atlantic County Bar Association under appropriate Federal and State provision. The Fund was given by Judge Rimm's family and will be maintained and administered by the Association with the income from the fund to be used for the purpose of the award.

The Atlantic County Bar Association makes a contribution to an Atlantic County charity on behalf of the recipient.

The award will be presented annually by the Atlantic County Bar Association in the fall of each year.

Nominations for the award may be submitted to the Selection Committee by the general public, judges of Atlantic County and members of the Association.

All nominations are to be submitted to the Committee within two weeks after publication of this notice.
